

A Guide to Accessible Voting in Provincial Elections



Our commitment to accessibility

Elections Ontario is committed to the customer service standards under the *Accessibility* for Ontarians with Disabilities Act. This is part of our vision for setting the standards for electoral process excellence in accessibility for returning offices, advance voting locations and election day voting locations in provincial elections.

These standards ensure that goods and services are provided to persons with disabilities in a manner that:

- respects their dignity and independence;
- is integrated unless an alternative measure is necessary (either temporarily or on a permanent basis); and
- is equal to the manner that goods and services are provided to others.



Voter registration

Accessible formats

Voting locations

Election officials are trained to offer accessible customer services to allow persons with disabilities to make their own choices when navigating the voting process.

Accessible tools and services include the following:

- Curbside voting, where the ballot is brought outside the voting location by an election official.
- Support persons to assist with communication, mobility, personal care for medical needs and/or accessing goods, services or facilities.
- Guide dogs or service animals (under constant care and control).
- Mobile phones and/or devices as an accessibility tool, including video remote interpreting applications (please note that it is illegal to take or share videos of completed ballots).
- Magnifying sheets and ballot templates with braille numbering and cut-outs.

You may also apply at your returning office to transfer to another voting location that better meets your accessibility needs.



Interpreters & intervenors

If you require an American Sign Language or Langue des Signes Québécoise interpreter, you may request a booking through Canadian Hearing Services. If you require an intervenor, you may request a booking through Canadian Hearing Services or the CNIB Deafblind Community Services. Elections Ontario will cover the cost of all bookings.

In Eastern and Western Ontario and the Greater Toronto Area, CNIB is the intervenor service provider. In Northern Ontario, Canadian Hearing Services is the intervenor service provider.

Assistive voting technology

Assistive voting technology at your returning office allows you to cast your ballot secretly and independently using your choice of the following controllers:

- Audio tactile interface: this controller has audio directions and features large, raised buttons, bright colours, and braille inscriptions.
- Paddles: can be pressed using hands, feet, or elbows.
- Sip and puff technology: this device allows you to mark your ballot by "sipping" (inhaling) or "puffing" (exhaling) into a straw.

Contact your returning office for hours of operation and availability. Walk-in requests may be accommodated where possible.



Voting by mail

Any elector may vote by mail in a provincial election. To choose this option, you must submit a completed application form and a copy of your ID. Visit <u>votebymail.elections.on.ca</u> or contact your returning office for more details.



Voting by home visit

Contact your returning office to request a home visit if you are:

- unable to go to the returning office because of a disability;
- unable to complete an application form; or
- someone who requires assistance.

Elections Ontario app

Get personalized election information by downloading our app from the App Store or Google Play and create an account to access the following information for provincial elections in Ontario:

- A digital version of your voter information card that can be scanned at the poll
- A full list of your voting locations and dates
- Customizable election notifications
- A list of candidates for your electoral district

The app has been designed to comply with the *Accessibility for Ontarians with Disabilities Act* and is compatible with most devices.
